The primary reason for going with the name "Choose Not to Use" was so we were not focused on solely one illegal drug or one illegal activity. Public shooting offered at SCALE training facility

With deer hunting rapidly approaching, public shooting hours are again being offered at the SCALE Regional Training Facility in rural Jordan. Range use will be monitored by trained range safety personnel during the public shooting times.

Public rifle and shotgun slug shooting dates and times are:

Saturday, Oct. 21: 10 a.m. - 2 p.m.
Sunday, Oct. 29: 12 noon - 4 p.m.

The fee to use the facility range is \$15 for 20 minutes of shooting time. Reservations are not required. Check the RTF website at www.scottcountymn.gov/833/Regional-Public-Safety-
